1. All materials supplied shall be of good quality and safe for public use.
2. The bidder shall comply with all safety, electrical and fire norms.
3. Any damage to public property during execution shall be made good by the contractor at his own cost.
4. Payment will be made after successful completion of the event and submission of bill, subject to the completion of the works.
5. No advance payment shall be made at any circumstances.
6. Penalty shall be imposed for delay, poor quality or non-performance from the bill amount due to the contractor/bidder.
7. The quoted amount shall include all the taxable amounts.No hidden charges shall be entertained
8. All unforeseen immediate requirements , shall be anticipated by the bidder and ready to accomplish in the time.
9. The site shall be ready to handover one day before the of launch of programme
